1. 52-09-SMS11. Formal A. 3996's will be completed as stipulated in the March 1, 1998 edition of the M-41 handbook Section 28 (a through m.) Management will cease and desist from writing comments on the 3996's.
2. 52-2009-MC27. Formal A. 3996's will be completed as stipulated in the March 1, 1998 edition of the M-41 handbook Section 28 (a through m.)
3. 52-2009-MC28. Formal A. The 1017-B entry (unauthorized overtime) for 9 units is hereby deleted from the Grievant's 1017-B log.
4. 52-09-SMS5. Formal A. Henceforth, management will enforce the AM Standard Operating Procedure (SOP) equitably.
5. 52-09-SMS9. Formal A. Management will address 3996's immediately.

12. 52-08-SMS4. Informal A. We withdrew the grievance when management changed the 8 hours of AWOL to 8 hours of sick leave.

14. 52-2009-MC25. Formal A. Management will immediately rescind the

instruction to sign or initial submitted gas purchase receipts when using the Voyager Gas Cards.

15. 52-09-TS02. Informal A. 14 DAY SUSPENSION alleging that the Grievant knocked over a mail receptacle with the vehicle is reduced to a Letter of Warning and further reduced from two years to 6 months in OPF.
